The Board has been holding workshops to discuss the proposed changes to the Bylaws and budget that were presented to the membership last year.

Last year's board had unanimously agreed to conduct a thorough review of the Bylaws to clear up inconsistencies, ambiguities, and gaps and to clarify and ensure compliance with other guiding documents and state law.

Proposed Budget

In the March 20th workshop, the BOD discussed the budget that was proposed last year. In the Bylaws, SAPOA levies an annual membership fee on all property owners. In Section 2.2 Voting Rights, it says: Each member is entitled to one vote for each lot or aggregate of lots owned, referring to voting rights, not dues. In the past, this has been interpreted different ways. The board discussed this at length and believed it was fair to all members to assess dues for 464 property owners-AND-clarify that each member is entitled to one vote for each property.

The budget also includes funding for member communications, legal fees, tax and audit preparation, reserve funding and insurance.

A new annual budget will be prepared and presented at the May BOD meeting.

New Website

Christine discussed the reason for the new website. The old Classic Google site platform, (outdated technology with known security issues) was being phased out by Google. We also had security and administrative access issues, and wanted to protect members from unsuspectingly downloading viruses or malware. A website developer built our new site in WordPress; and Christine maintains it. We are now capable of adding enhancements like online invoicing and online payments on this new platform.

DP Transit Committee

We have been made aware of members who are concerned about the lack of transportation from Diamond Point to medical facilities in Sequim. The BOD is interested in forming a committee to discuss better transportation—not just for SAPOA members but for the DP community as a whole. Christine offered to chair the committee, but is looking for volunteers. Please contact Christine through the Contact Us on our website or at
